Candidates to also mention the expected salary in their mail itself. **Candidate who has earlier appeared in the Interview for the post of Cargo Certified Security Screener cannot apply again.** The last date of receipt of applications is **15.06.2024**.

7 GENERAL CONDITIONS:

- i. The short-listed eligible candidates will be considered for engagement on a Fixed Term Contract basis (FTC) initially for a period of three years and further extendable by a period of two years subject to their Medical Fitness, on job performance and meeting all eligibility conditions, prescribed for the position. The period of one year (for all positions) will be treated as probation period and on successful completion of probation period, the period of engagement will be considered for extension at the sole discretion of the Management of CHIAL.
- ii. The FTC will be renewable at the sole discretion of the management of CHIAL only subject to satisfactory performance.
- iii. The Contract could be terminated earlier at the discretion of the Management during the validity of the contract, and/or in the event of unsatisfactory performance.
- iv. The applicant must ensure that they fulfill all the eligibility criteria, as on **10/05/2024**, and that the particulars furnished by him/her in the application are correct in all respects. At any stage of the Selection Process, if the particulars furnished by the applicants in the application or testimonials attached/provided are found to be incorrect / false, or not meeting with the eligibility criteria prescribed for the position, the candidature is liable to be rejected and, if engaged, engagement will be terminated, without giving any notice or reasons thereof.
- v. Any canvassing by or on behalf of the candidate or bringing political or other outside influence, with regard to their engagement / selection shall be considered as DISQUALIFICATION.

- viii. CHIAL will not bear any liability on account of service bond/salary/leave salary pension contribution etc. if any, of previous employment of any candidate working in Central/ State Government/Autonomous Body/ Public Sector Undertaking.
- ix. Firm no. of vacancies will be determined at a later stage. CHIAL may also increase or decrease the number of positions, without assigning any reasons whatsoever.
- x. The selected candidates can be deputed in any department of the Company and will have to perform all the screening and allied services including operation etc., as per the requirement of the company.
- xi. Selected Candidates will have to bear the cost of the Pre-Engagement Medical Examination(s).
